

On their recruitment page, CDC has stated that no CDC employee will be required to take the COVID vaccine.

CDC is **NOT implementing or enforcing Executive Order 14043** federal employee COVID-19 vaccination requirements. On January 21st 2022 **a preliminary injunction** was obtained by Federal Employees for Freedom, preventing the mandating of COVID-19 vaccines for Federal workers.

It is likely that this injunction will be upheld, since without it all CDC workers would be forced to take the jab, and there are those at the CDC who KNOW 100% about all the millions of horrible adverse reactions that the COVID vaccine has caused.

Why did Federal government workers take out an injunction prohibiting the implementation or enforcing COVID-19 vaccination, in defiance of Biden's executive order 14043?

To ensure compliance with an applicable preliminary nationwide injunction, which may be supplemented, modified, or vacated, depending on the course of ongoing litigation, the Federal Government will take no action to implement or enforce the COVID-19 vaccination requirement pursuant to Executive Order 14043 on Requiring Coronavirus Disease 2019 Vaccination for Federal Employees. Therefore, to the extent a Federal job announcement includes the requirement that applicants must be fully vaccinated against COVID-19 pursuant to Executive Order 14043, that requirement does not currently apply. Federal agencies may request information regarding the vaccination status of selected applicants for the purposes of implementing other workplace safety protocols, such as protocols related to masking, physical distancing, testing, travel, and quarantine.

The injunction prohibited the enforcement of a vaccine mandate for federal employees. It was appealed and the appeal is pending before the Fifth Circuit Court of Appeals (rehearing granted before full panel of judges).
