

Distribution of toxic Pfizer lots - what % of reports are severe?

Data is extracted from the VAERS database and was last updated on 24th June 2022. You can carry out your own searches here –

Toxicity varies from country to country. For example – the Pfizer lot EW6126 has a severity of 60% in Belgium, but EW lots in the UK have a maximum severity of 13%. So there is large geographical variation.

Toxicity of Vaccine Lots in the UK

Here are the 10 most toxic Pfizer lots being dispensed in the UK

As you can see, the % of reports that are severe for each lot varies between 18% and 23%.

So, in the UK between 1 in 5 and 1 in 4 of reported adverse reactions for these lots are of a severe nature. The severity of these severe reactions often involve permanent disability, severe pain or chronic illness – none of which can be described as temporary or transient. All of these severe reactions involve severe damage to the cardio vascular system, to the nervous system or to other critical organs within the body. The majority of these severe reactions occur within 24 hours of the vaccination, and the mechanism is both logical and well understood.

So you can see that there is large variation in the severity of different lots – just browse the data for yourself – viewed here -

Not all lots produce an immediate severe reaction – but some certainly do.

What about other countries? Let's look at Belgium

Here are the 10 most toxic Pfizer lots being dispensed in Belgium -

As you can see, the % of reports that are severe for each lot varies between 69% and 93% !

It looks as if some countries are experiencing a far greater frequency of severe reactions compared to the UK – in fact about 4 times more.

What about Sweden?

Sweden has a reputation for rational and humanitarian government. Perhaps that's why they were targeted with particularly nasty lots. Here are the 10 most toxic lots being dispensed in Sweden –

As you can see, the % of reports that are severe for each lot varies between 54% and 64% !

When we say that the severity of a lot is over 54% - we mean that more than 54% of the reported adverse reactions for those lots resulted in permanent disability or death. This is far higher than the 23% maximum found for lots distributed in the UK.

We can only wonder why rational, truly democratic countries – like Belgium and Sweden – have been targeted with such toxic lots. These lots were contrived to maximize suffering, since they resulted in a great excess of incapacitating disability and endless pain, rather than a quick death.

Rationality confers resistance to propaganda, and one way to break the back of resistance is to target such rational countries with excessive suffering.

Is this toxicity deliberate?

Governments and pharma are **well aware** of the excess toxicity of certain vaccine lots, but have **failed to warn** the public of it. On the contrary, they are **actively denying and censoring** information about this toxicity – and instead they are **mandating and coercing** vaccine uptake with a total absence of informed consent (no information on toxicity being given).

It would seem, therefore, that governments, pharma, and regulatory agencies have an **intention to harm**.

Once we accept that they have such an intention to harm, then we can understand why such an intention must be kept covert, since an obvious intention to harm would lead to public resistance. Consequently the incidence of toxicity must be kept **at the 5% level** in order to remain below the level of public perception.

What we can see, in the data above, is that only certain lots are excessively toxic, and the level of that toxicity is such that sometimes up to 93% of reports for a particular lot end in death, permanent disability or chronic illness.

It is good that we have this clear perspective on the variation between lots

Conclusion

- Not all lots are equal – some are far more toxic than others
- The clear intention of world governments is to harm, and this can only be achieved in a covert manner - by interspersing harmless lots with highly toxic ones.
