

U.K. Exemptions for injections, masks, tests

(or for ANY medical intervention and/or procedure)

Point 1 : Exemptions are NOT required!!!

To every living man, woman or child in the U.K.:

YOU have the INALIENABLE, FUNDAMENTAL RIGHT to REFUSE any medical intervention and or treatment even if the refusal leads to your death.

You do **NOT** have to:

1. Explain yourself
2. Justify yourself
3. Prove a religious or any other objection

You have Sovereignty over your own body and mind:

“Voluntas aegroti suprema lex” - Over his or her own mind and body, the Individual is Sovereign

(John Stuart Mill, “On Liberty”). i.e. “Bodily Integrity”, and that includes Sovereignty to refuse or accept medical treatment/intervention/procedures.

Point 2 : How do you assert this Right?

You simply say:

“NO - I do NOT want this medical treatment/intervention/procedure.”

That’s it!

NO-ONE has the right to derogate from your **inalienable, fundamental Right to Bodily Integrity** - including your MPs in government, your employer, your doctor/medical team, your council, your school or college or your University or any corporation or other entity.

HM the Queen - as Head of State- does not have the right to derogate from your inalienable, fundamental Right to Bodily Integrity.

This Right to Bodily Integrity cannot be derogated from - even in times of War or Public Health Emergency.
